Vendor Beverage Restrictions

Summary for Drink Sales Restrictions for Vendors:

You may purchase Dasani water and Coca Cola products from the SC State Chili Cook-Off Committee at a reduced cost for resale.

Water: \$1.00 ea.

Soft drinks: \$1.50 ea.

You may pick up your cases the morning of the event at the Coke Tent

You must sell the products at the same price as the Committee is selling them at the Coke Tent.

Water: \$3.00 ea.

Soft drinks: \$4.00 ea.

You are limited to 2 cases (24 ct. ea.) of water and 5 cases (24 ct. ea.) of soft drinks. When you run out, please send customers to the Coke Tent to purchase their drinks.

You may serve homemade lemonade or tea. No bottles.

No Pepsi products may be served.
